WHAT IS AN IMAGE

- The word image (Hebrew *tselem* תְּלֵמָה) is used 15 times 9 in the Hebrew Bible. The basic meaning of the root means a “shadow” cf. Genesis’ Hebrew Lexicon.10 Based on its usage we can confidently deduce the following definition: ‘a living or nonliving representation of something else.’
- God states in Genesis 1:26-27 that He made Adam in his image. “Then God said, ‘Let Us make man in **Our image**, according to **Our likeness**’ [...] So God created man in His own image; in the **image of God** He created him; male and female He created them” (Gen. 1:26-27)
- When Adam had lived 130 years, he fathered a son in his own likeness, after his **image**, and named him Seth (Genesis 5:3).



THE GENESIS PROPHECY AND THE TWO SEEDS

- ¹⁵ And I will put enmity
Between you and the woman,
And between **your seed** and **her Seed**;
He shall bruise your head,
And you shall bruise His heel.”
(Genesis 3:15)



SATAN'S PLAN TO DESTROY THE IMAGE

- Satan will one day mix his seed with humanity to bring forth the Antichrist as a counterfeit of the incarnation of Jesus.
- Genesis 6
- The Nephilim were on the earth again and had overrun the land of Canaan.
- 10 kings mingle (hybridize) themselves with the seed of men (Daniel 2:43).
- As it was in the days of Noah...(Matthew 24:37).



THE BOTTOM LINE

- Enmity = antithetical, opposite, converse, contradictory
- If “her seed” equals Christ, then “your seed” must be its antithesis, thus:
antichrist



EZEKIEL 1:26

- ²⁶ And above the firmament that was over their heads was the likeness of a throne, as the appearance of a sapphire stone: and upon the likeness of the throne was the likeness as the appearance of a **man** above upon it. ²⁷ And I saw as the color of amber, as the appearance of fire round about within it, from the appearance of his loins even upward, and from the appearance of his loins even downward, I saw as it were the appearance of fire, and it had brightness round about. ²⁸ As the appearance of the bow that is in the cloud in the day of rain, so was the appearance of the brightness round about. This was the appearance of the likeness of the glory of the LORD. And when I saw it, I fell upon my face, and I heard a voice of one that spake.



PROPHETS SEEING GOD



- I saw the Lord **sitting** on a throne, high and lifted up, and the train of His robe filled the temple, (Isaiah 6:1).
- I watched till thrones were put in place, and the Ancient of Days was **seated**; His garment was white as snow, and the **hair** of His **head** was like pure wool. ~~His throne was a fiery flame, its wheels a burning fire,~~ (Daniel 7:9).



ONE LIKE THE SON OF MAN

- One like the Son of Man, clothed with a garment down to the feet and girded about the chest with a golden band. His head and hair were white like wool [like Daniel 7:9], as white as snow, and His eyes like a flame of fire; His feet were like fine brass, as if refined in a furnace, and His voice as the sound of many waters; He had in His right hand seven stars, out of His mouth went a sharp two-edged sword, and His countenance was like the sun shining in its strength. (Revelation 1:12-18).



CLOTHED IN LIGHT

- Then the righteous will shine forth [*eklampo* ἐκλάμπω] as the sun in the kingdom of their Father. He who has ears to hear, let him hear! (Matthew 13:43)
- Those who are wise shall shine [LXX: *eklampo* ἐκλάμπω] Like the brightness of the firmament, And those who turn many to righteousness Like the stars forever and ever. (Daniel 12:3)
- "it was granted her to clothe herself with fine linen, bright [λαμπρον] and pure - for the fine linen is the righteous deeds of the saints." (Revelation 19:8 ESV)



SUPPORTED BY ANCIENT JEWISH INTERPRETATION

- The Midrash Rabbah (Rabbinic literature from the first or second century AD) of Genesis 3:21 reads, "AND THE LORD GOD MADE FOR ADAM AND HIS WIFE GARMENTS OF SKIN [עֹר וְרֵס], AND CLOTHED THEM (III, 21). In R. Meir's Torah it was found written, 'Garments of light (or)' this refers to Adam's garments, which were like a torch, broad at the bottom and narrow at the top."



DNA EMITS LIGHT

MOSES' SHINING FACE

- Now it was so, when Moses came down from Mount Sinai [...]



that Moses did not know that the **skin of his face shone** [פָּנָיו עִוֵּר קָרָן] while he talked with Him. So when Aaron and all the children of Israel saw Moses, behold, the **skin of his face shone**, and they were afraid to come near him... (Exodus 34:29-30, 33).



THE SEED OF ABRAHAM AND OF DAVID

- God ... saying unto Abraham, And **in thy seed** [*sperma σπέρμα*] shall all the kindreds of the earth be blessed, (Acts 3:25 KJV).
- Concerning His Son Jesus Christ our Lord, who was born of the **seed of David** [*spermatos David σπερματος δαβιδ*] according to the flesh, (Romans 1:3).
- Remember that Jesus Christ, of the **seed of David** [*spermatos David σπερματος δαβιδ*] (2 Timothy 2:8).



THE VIRGIN WILL CONCEIVE

- And behold, **you will conceive** [*sullepse* συλληψη] in **your womb** [*gastri* γαστρι] and **bring forth** a Son, and shall call His name JESUS. [...] and the Lord God will give Him the throne of **His father David** [...] " ... "The **Holy Spirit will come upon** [*epeleusetai* επελευσεται] you, and the power of the **Highest will overshadow you**; therefore, also, that Holy One who is to be born will be called the Son of God.



THE GENETICS OF THE MESSIAH BECOMING FLESH

- The incarnation of Jesus was nothing less than the genetic combination of the celestial (Holy Spirit) and the terrestrial (Mary). We must stress, however, that Jesus as the second person of the Godhead existed from eternity past (Micah 5:2) and did not begin to exist at the Holy Spirit's overshadowing of Mary – He is eternal and has always existed.



JUST WHAT IS A SEED?

- DNA is the source code of humanity and it is the essence of the “seed” that Scripture so often talks about. The term seed is in modern terms called a gamete which in the male is the sperm and in the female is the ovum. Thus when Mary conceived it meant that her ovum provided 23 chromosomes and hence the Holy Spirit provided the other gamete (23 chromosomes).



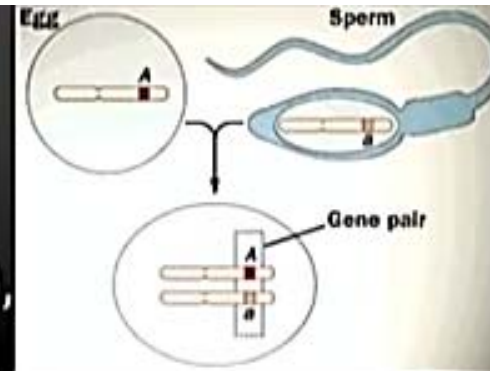
NORMAL CONCEPTION

- During reproduction, the maternal and paternal gametes (haploid cells), “fuse at conception to produce a zygote, which will turn into a fetus and eventually into an adult human being.”

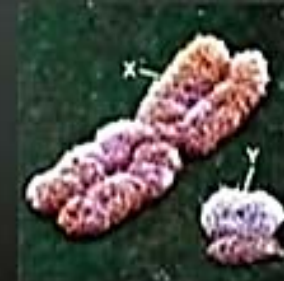
ADAM PASSED HIS Y CHROMOSOME

- “Genesis, chapter 5, records ‘the generations of Adam:’ Adam begat Seth, Seth begat Enosh... down to Noah of the flood. Translated into modern genetic terms, the account could read **‘Adam passed a copy of his Y chromosome to Seth, Seth passed a copy of his Y chromosome to Enosh, Enosh passed a copy of his Y chromosome to Kenan’... and so on until Noah was born carrying a copy of Adam’s Y chromosome.**”

FAULTY Y CHROMOSOME



- The Y chromosome may in fact be a record of an event in the life of our original father. Bradman and Thomas suggest that the Y chromosome contains “a record of an event” in the life the man who passed on the current Y chromosome, which they say: “had no effect on the life of the man in whom the change occurred nor, indeed, **on the life of his descendants**,”. Is it possible that the recorded event is not something that had “little or no effect,” but is in some way the record of the genetic fall of our first father?

REBORN WITH THE SEED OF THE MESSIAH

- Yet it pleased the LORD to bruise Him; He has put Him to grief. When You make His soul an offering for sin, He shall see His **seed** [*zera* זֵרָע], (Isaiah 53:10)
- “Whoever has been born of God does not sin, for His **seed** [*sperma* σπέρμα] remains in him and he cannot sin, because he has been born of God,” (1 John 3:9).
- “having been born again, not of corruptible **seed** but incorruptible, through the word [*logos* λόγος] of God which lives and abides forever,” (1 Peter 1:23)



REBORN WITH A NEW IMAGE

- **“Truly, truly I tell you, unless a person is born from above he cannot see the kingdom of God.”** [...] What is born of the flesh is flesh, and what is **born of the Spirit is spirit.** Do not be astonished that I said to you, **‘All of you must be born from above.’** (John 3:3-7 ISV).
- **“Therefore, if anyone is in Christ, he is a new creation; old things have passed away; behold, all things have become new,”** (2 Corinthians 5:17).
- **“For in Christ Jesus neither circumcision nor uncircumcision avails anything, but a new creation,”** (Galatians 6:15).



THE NATURAL ORDER ESTABLISHED

- And God made the beast of the earth according to its kind, cattle according to its kind, and everything that creeps on the earth according to its kind. And God saw that [*it was*] good. (Genesis 1:25)



THE SONS OF GOD IN THE DAYS OF NOAH

- When humankind began to multiply on the face of the earth, and daughters were born to them, the **sons of God** [*benei haelohim* בְּנֵי-הָאֱלֹהִים] saw that the **daughters of humankind** [*banot haadam* בָּנוֹת הָאָדָם] were beautiful. Thus **they took wives** for themselves from any they chose. So the LORD said, "My spirit will not remain in humankind indefinitely, since they are mortal. They will remain for 120 more years." The **Nephilim** were on the earth in those days (and also after this) when the **sons of God** were having **sexual relations with the daughters of humankind, who gave birth to their children.**" (Genesis 6:1-7 NET).
- There were conceivably over ten billion people at the days of Noah.



THE SONS OF GOD

- The phrase the “sons of God” appears ten times in the Bible (NKJV); twice in Genesis six, three times in the book of Job and five times in the New Testament.
- “When the morning stars sang together, and all the sons of God shouted for joy?” (Job 38:7).
- Now there was a day when the sons of God (*oi angeloi tou theou* οι αγγελοι του θεου) came to present themselves before the LORD, and Satan also came among them.” (Job 1:6)



THREE VIEWS OF THE SONS OF GOD

- (1) In the Book of Job the phrase clearly refers to angelic beings.
 - In Genesis 6 the “sons of God” are distinct from “humankind,” suggesting they were not human. This is consistent with the use of the phrase in Job. Since the passage speaks of these beings cohabiting with women, **they must have taken physical form or possessed the bodies of men.**
- (2) members of Seth’s line, “daughters of humankind” were descendants of Cain.
 - But, as noted above, the text **distinguishes the “sons of God” from humankind (which would include the Sethites as well as the Cainites)** and suggests that the “daughters of humankind” are **human women in general, not just Cainites.**
- (3) the “sons of God” as powerful tyrants, perhaps demon-possessed, who viewed themselves as divine (see Gen 4:19), practiced polygamy. **But usage of the phrase “sons of God” in Job militates against this view.** (NET Notes Genesis 6:2, emphasis mine)



NEITHER MARRY NOR ARE GIVEN IN MARRIAGE

- "For in the resurrection they neither marry nor are given in marriage, but are like angels in heaven." (Matthew 22:30)
- "But those who are considered worthy to attain to that age and to the resurrection from the dead neither marry nor are given in marriage, **for they cannot die anymore, because** they are equal to angels and are sons of God, being sons of the resurrection," (Luke 20:35-36).
- It was not: the ***ability*** to pass on seed



FALLEN ANGELS ACCORDING TO THE NT

- “For if God did not spare **the angels who sinned**, but threw them into hell [*tartarosas* ταρταρώσας] and locked them up in chains in utter darkness, to be kept **until the judgment**, and if he did **not spare the ancient world**, but did protect Noah, a herald of righteousness, along with seven others, when God brought a flood on an ungodly world, and if he **turned to ashes the cities of Sodom and Gomorrah when he condemned them to destruction**, [...] and to reserve the unrighteous for punishment at the day of judgment, **especially those who indulge their fleshly desires** and who despise authority,” (2 Peter 2:4-10 NET).



JUDE

- You also know that the **angels** [*angelous* αγγελους] who did **not keep within their proper domain** [*arkhen* αρχην] but abandoned **their own place of residence** [*oiketerion* οικητηριον], he has kept in eternal chains in utter darkness, locked up for the judgment of the great Day. So also [*hos* ως] Sodom and Gomorrah and the neighboring towns, since they indulged in sexual immorality [*ekporeusasai* εκπορνευσασαι] and **pursued unnatural desire** [*sarkos heteras* σαρκος ετερας] **in a way similar to these** [*toutois* τουτοις] **angels**, are now displayed as an example by suffering the punishment of eternal fire, (Jude 1:5-7 NET).



THE NEW AMERICAN BIBLE CONFIRMATION

- However, the phrase “practiced unnatural vice”—translated literally as “went after alien flesh”—refers to the desires for sexual intimacies by human beings with angels, which is the reverse of the account in Genesis, where heavenly beings (angels) sought after human flesh. *New*

PRE-NEW TESTAMENT JEWISH TEXTS

- Ancient Jewish sources a century or two before or after Jesus Enoch
 - Tales of the Patriarchs (also known as the Genesis Apochryphon)
 - Philo
 - the Aramaic Targumim of the Pentateuch
 - Josephus and others
- They consistently accepted the interpretation that fallen angels were capable of producing offspring and therefore had some kind of genetic seed to pass on.



THE BOOK OF I ENOCH

- (1) It happened after the sons of men had multiplied in those days, that daughters were born to them, elegant and beautiful.
- (2) And when the **angels, the sons of heaven ...**
- (10) Then they took wives, each choosing for himself; whom they began to approach, and with whom they cohabited; teaching them sorcery, incantations, and the dividing of roots and trees.
- (11) And the women conceiving brought forth **giants,**



PHILO'S INTERPRETATION

- And when the **angels of God** saw the daughters of men that they were beautiful, they took unto themselves wives of all of them whom they Chose." [Gen 6:2] Those beings, whom other philosophers call **demons**, Moses usually calls **angels**; and they are souls hovering in the air, (Philo, *On the Giants*, II, 6 emphasis mine).
- On what principle it was that giants were born of **angels** and women? The poets call those men who were **born out of the earth** giants, that is to say, sons of the Earth.
- But he relates that **these giants were sprung from a combined procreation of two natures, namely, from angels and mortal women**; (Philo, *Questions and Answers on Genesis* part 4, note 92 emphasis mine).



PHILO ON THE SIZE OF THE GIANTS

- “they saw that they were very numerous indeed, and **giants of exceeding tallness with absolutely gigantic bodies**, both as to their magnitude and their strength,” (emphasis mine).

JOSEPHUS

For many **angels** of God **accompanied with women**, and **begat sons** that proved unjust, and despisers of all that was good, on account of the confidence they had in their own strength; for the tradition is, that these **men did what resembled the acts of those whom the Grecians call giants**, (Josephus *Antiquities of the Jews* chapter 3 footnote 11).

“This notion, that the fallen angels were, in some sense, the fathers of the old giants, was the constant opinion of antiquity.” William Whiston, the translator of Josephus



THE TESTAMENTS OF THE TWELVE PATRIARCHS

- For thus they allured the **Watchers** who were before the flood; for as these continually beheld them, they lusted after them, and they conceived the act in their mind; And the women lusting in their minds after their forms, **gave birth to giants, for the Watchers appeared to them as reaching even unto heaven,**
(Testament of Reuben 18-20).



AUGUSTINE OF HIPPO

- “But God's holy angels could not fall in such fashion before the deluge. Hence by the **sons of God** are to be understood the **sons of Seth**, who **were good**; while by the **daughters of men** the Scripture designates those who sprang from the **race of Cain**.” (Augustine *St. Augustine's City of God and Christian Doctrine*)

- If the term “sons of God” refers to the “sons of Seth” as so many suggest, then why does the text not simply state it?



CALVIN'S INTERPRETATION



- That ancient figment, concerning the **intercourse of angels with women**, is abundantly refuted by its own absurdity; ... it is surprising that learned men should formerly have been fascinated by ravings so gross and prodigious.
- Moses, then, **does not distinguish** the sons of God from the daughters of men, **because they were of dissimilar nature, or of different origin**; but **because they were the sons of God by adoption, whom he had set apart for himself**; while the rest remained in their original condition, (Calvin Commentary Genesis 6:1).



WHO WERE THE NEPHILIM?

- “The Nephilim [*hanephilim* הַנְּפִילִים] were on the earth in those days, and also afterward, when the sons of God came in to the daughters of man and they bore children to them...” (Genesis 6:4 ESV)
- Nephilim - *naphal*: to fall
- The Greek Septuagint, “the giants” (*oi gigantes* οἱ γίγαντες). Classical Greek literature: men or creatures that were half god and half man.

THE AMORITES

- His Angel would go “before you and bring you in to the **Amorites** [...] and I will cut them off. You shall not bow down to their gods, nor serve them, nor do according to their works; but you shall utterly overthrow them and completely break down their sacred pillars, (Exodus 23:23, 24).
- We find that the Amorites were still in the land into the time of Judges from the passage “do not fear the gods of the **Amorites** in whose land you dwell” (Judges 6:10).



THE SIZE OF THE NEPHILIM

- “The Amalekites dwell in the land of the Negeb. The Hittites, the Jebusites, and the **Amorites** dwell in the hill country.[...]” Then the men who had gone up with him said, “We are not able to go up against the people, for they are **stronger** than we are.”
- “The land, through which we have gone to spy it out, is a land that devours its inhabitants, **and all the people that we saw in it are of great height**. And there we saw the **Nephilim** (the sons of Anak, who come from the **Nephilim**), and we seemed to ourselves like grasshoppers, and so we seemed to them” (Numbers 13:29-33, ESV).



GOD DESTROYED THE AMORITES

- “Yet it was I who destroyed the **Amorite** before them, Whose height was like the **height of the cedars**, And he was as strong as the oaks; Yet I destroyed his fruit above And his roots beneath,” (Amos 2:9).
- “Look now at the behemoth, which I made along with you; He eats grass like an ox. See now, his strength is in his hips, and his power is in his stomach muscles. He moves **his tail like a cedar**,” (Job 40:15-18).



SIZE OF A CUBIT IN MOSES' DAY

- For only Og king of Bashan remained of the remnant of the Rephaim [NKJV Giants]; behold, his bedstead was a bedstead of iron; is it not in Rabbah of the children of Ammon? **nine cubits** was the length thereof, and **four cubits** the breadth of it, after the cubit of a man, (Deuteronomy 3:11 JPS).
- Oxford Dictionary a cubit: An ancient measure of length derived from the forearm; varying at different times and places, but usually 18 to 22 inches. ~~The Roman cubit was 17.4 inches; the Egyptian 20.64 inches.~~



ONLY THE EGYPTIAN CUBIT FITS

- Tim Lovett, an expert on ancient shipbuilding, ...notes that the shortest was the Greek Short Cubit of 14 inches (356 millimeters) and among the longest were the Persian (Royal) cubit of 25.2 inches (640 millimeters) and the Arabic (Hashimi) of 25.56 inches (649 millimeters).

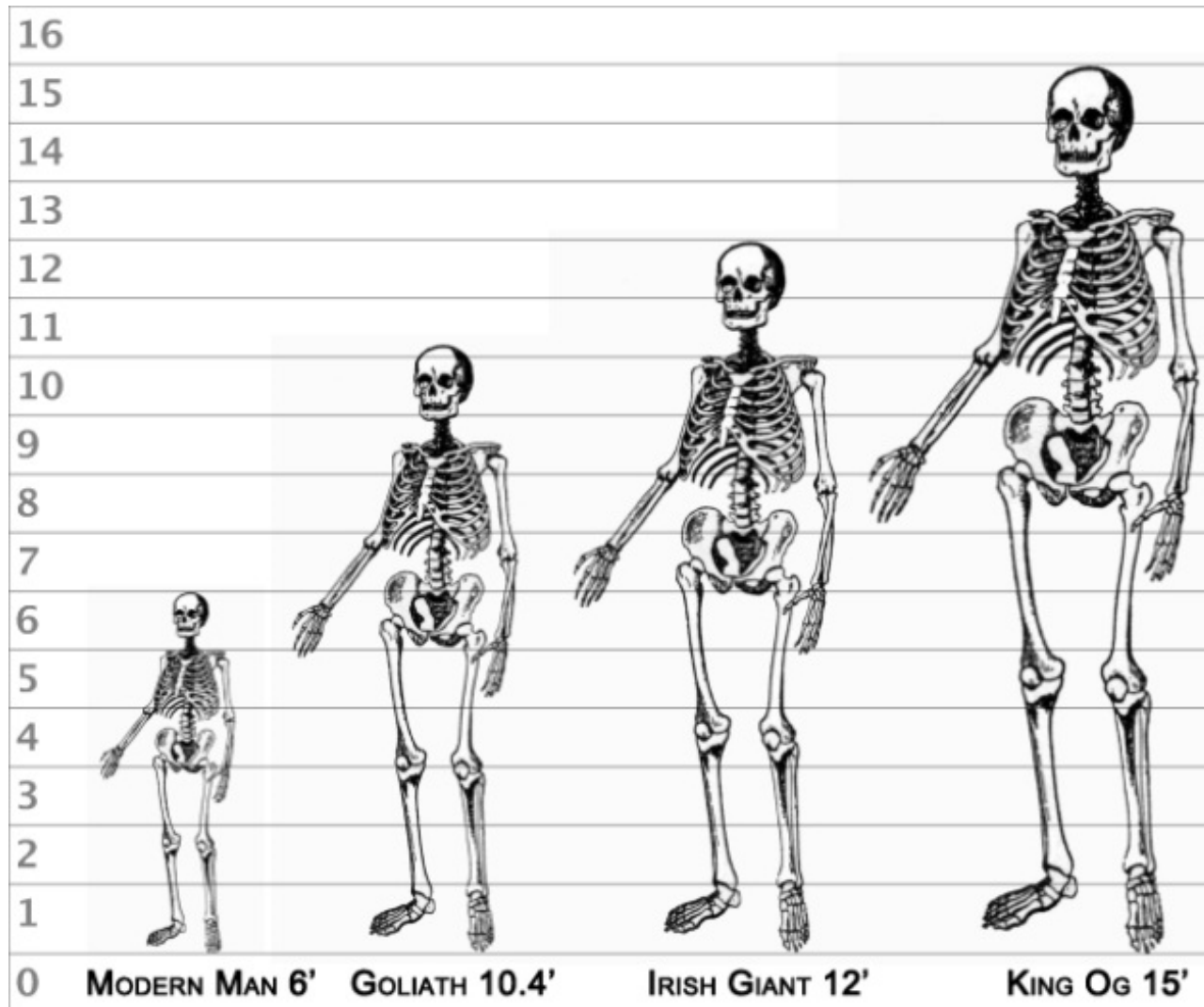
- The Greek, Persian and Arabic Empires were not around in Moses' day.



KING OG'S BED

- It was almost fifteen feet six inches (15.47 feet 4.716 meters) long and its width six feet ten inches (6.87 feet, 2.094 meters)!
- the bed was made of iron which would preclude the idea that a small man with a big ego slept on it.
- Og must have been slightly shorter than the bed that he slept on and therefore make him roughly 15 feet (4.55 meters) tall!





HOW HEAVY WAS KING OG?

- To calculate King Og's weight we need the cube of 2.5 which is 15.625. That is to say that King Og of Bashan would have weighed 15.625 times more than a six foot man today
- Thus he would weigh ($15.625 \times 200 =$) 3125 pounds (1420 kilograms).
- Considering that King Og was a warrior, we can presume that he could at least lift the equivalent of his own body weight (a 200 hundred pound man can potentially lift 400-500 pounds or 2 times his own body weight).
- He would have been able to lift two war horses (1500 pounds each)! In modern terms he could lift a midsize car!



A LAND THAT DEVOURS ITS INHABITANTS

- 22,657 calories per day just to stay alive as per the Basal Metabolic Rate
- Equal to nine normal sized persons.
- Converted into pizzas he would need 12 – 12 inch pizzas (1840 calories each). If we convert that to cheeseburgers then he would need 63 cheeseburgers daily and converted into lamb he would consume a lamb about every two days
- He might have had the equivalent of over 30 pizzas or 150 cheeseburgers per day!



THE FOSSILIZED IRISH GIANT

- ...at the London and North-Western Railway Company's Broad street goods depot, and a photograph of which is reproduced here... This monstrous figure is reputed to have been dug up by a Mr. Dyer whilst prospecting for iron ore in County Antrim.
- Length, 12 ft. 2 in.; girth of chest, 6 ft. 6 in.; and length of arms, 4 ft. 6 in. **There are six toes on the right foot.** [...] it took half a dozen men and a powerful crane to place this article of lost property in position for the Strand magazine artist. (Strand Magazine December 1895, C.F. Wood-Martin, 1901:58, emphasis mine)

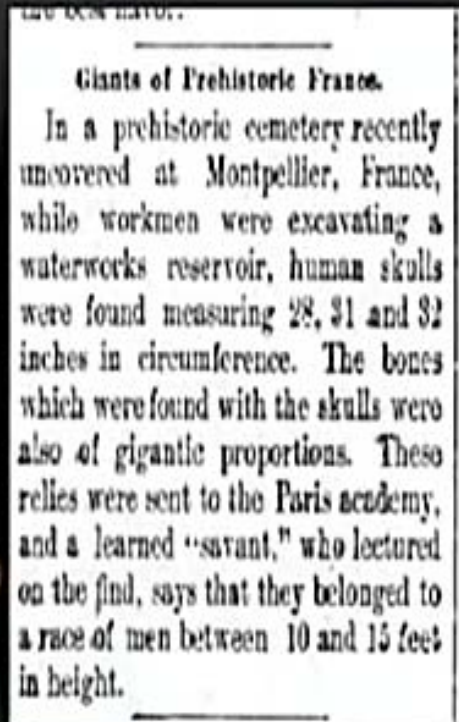


GIANTS OF PREHISTORIC FRANCE

- In a prehistoric cemetery recently uncovered at Montpellier, France, while workmen were excavating a waterworks reservoir, human skulls were found measuring 28, 31 and 32 inches in circumference. The bones that the workmen discovered were also of gigantic proportions. [...] One of the **scientists engaged in examining the skeletons says that they belonged to a race of men who stood between 10 and 15 feet in height,** (Emphasis mine).

SUMMARY

- Therefore, they are demons

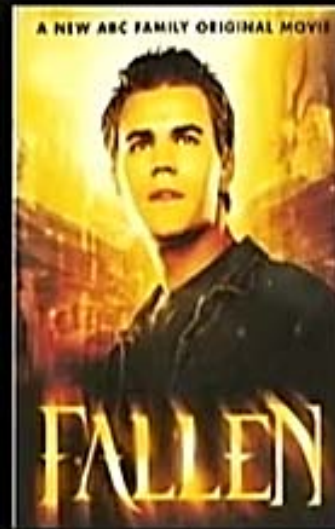

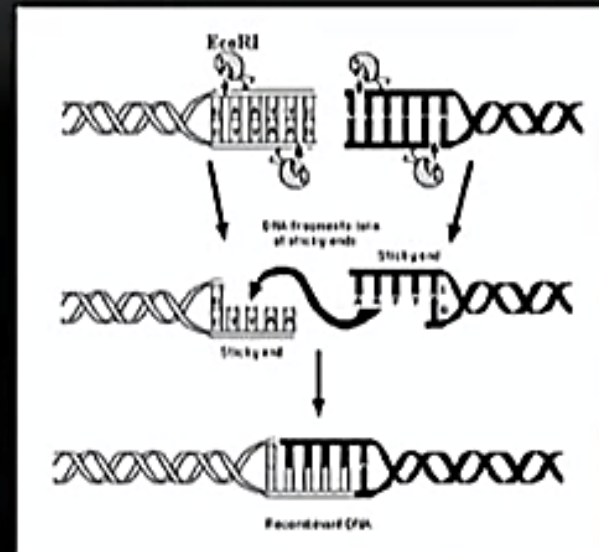


THE MARK OF THE BEAST

TWO PATHS BEFORE THE WORLD

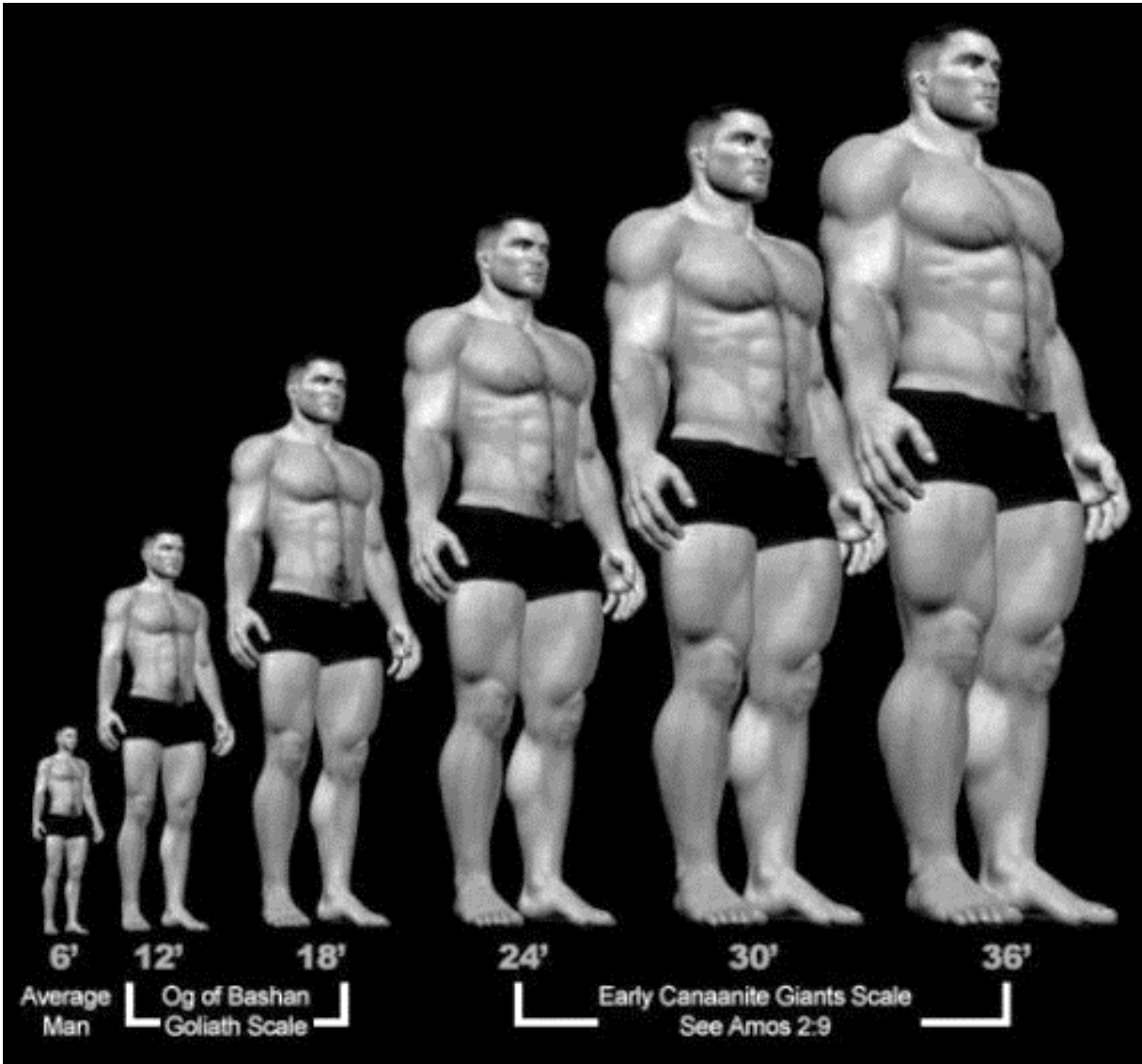

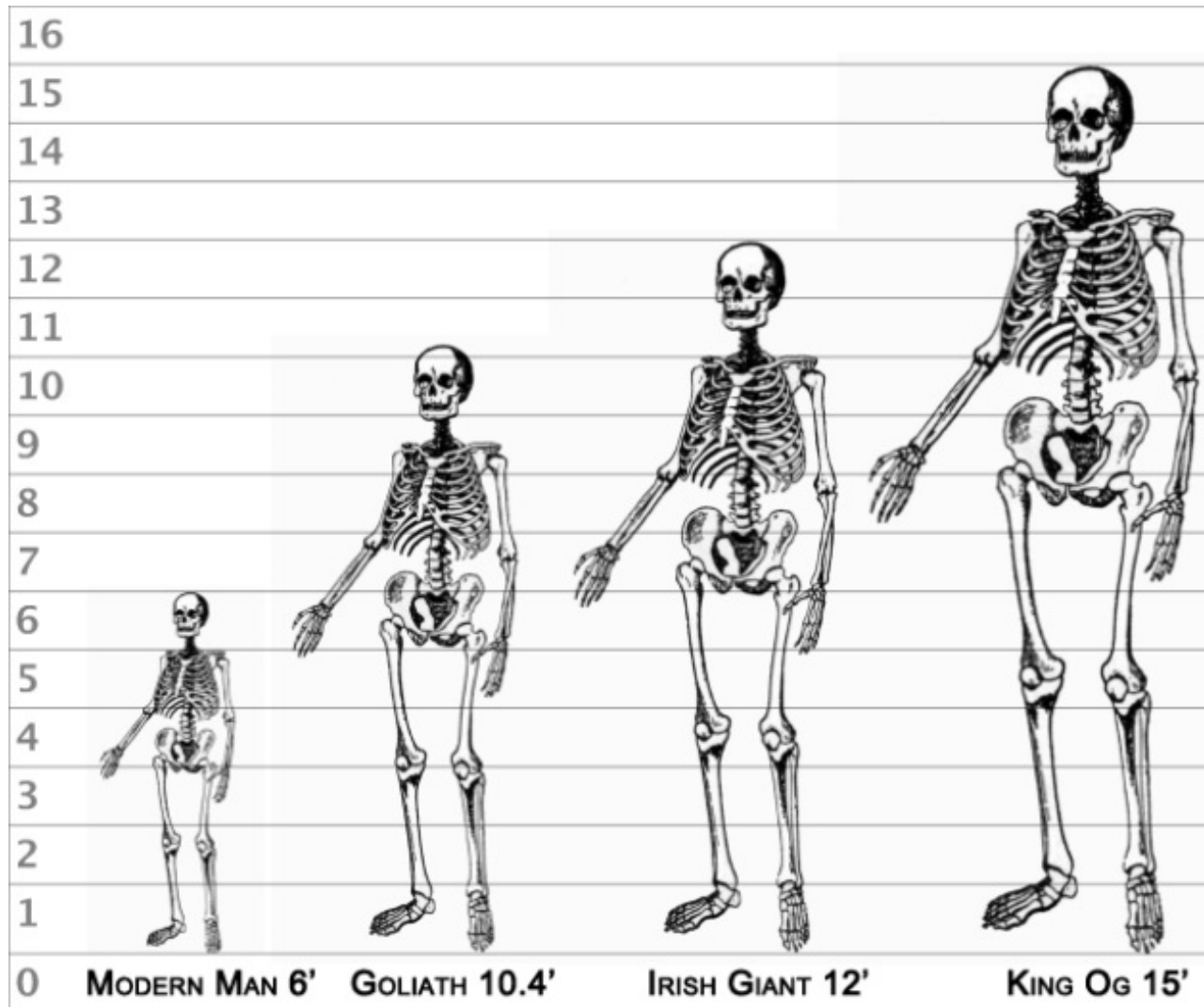


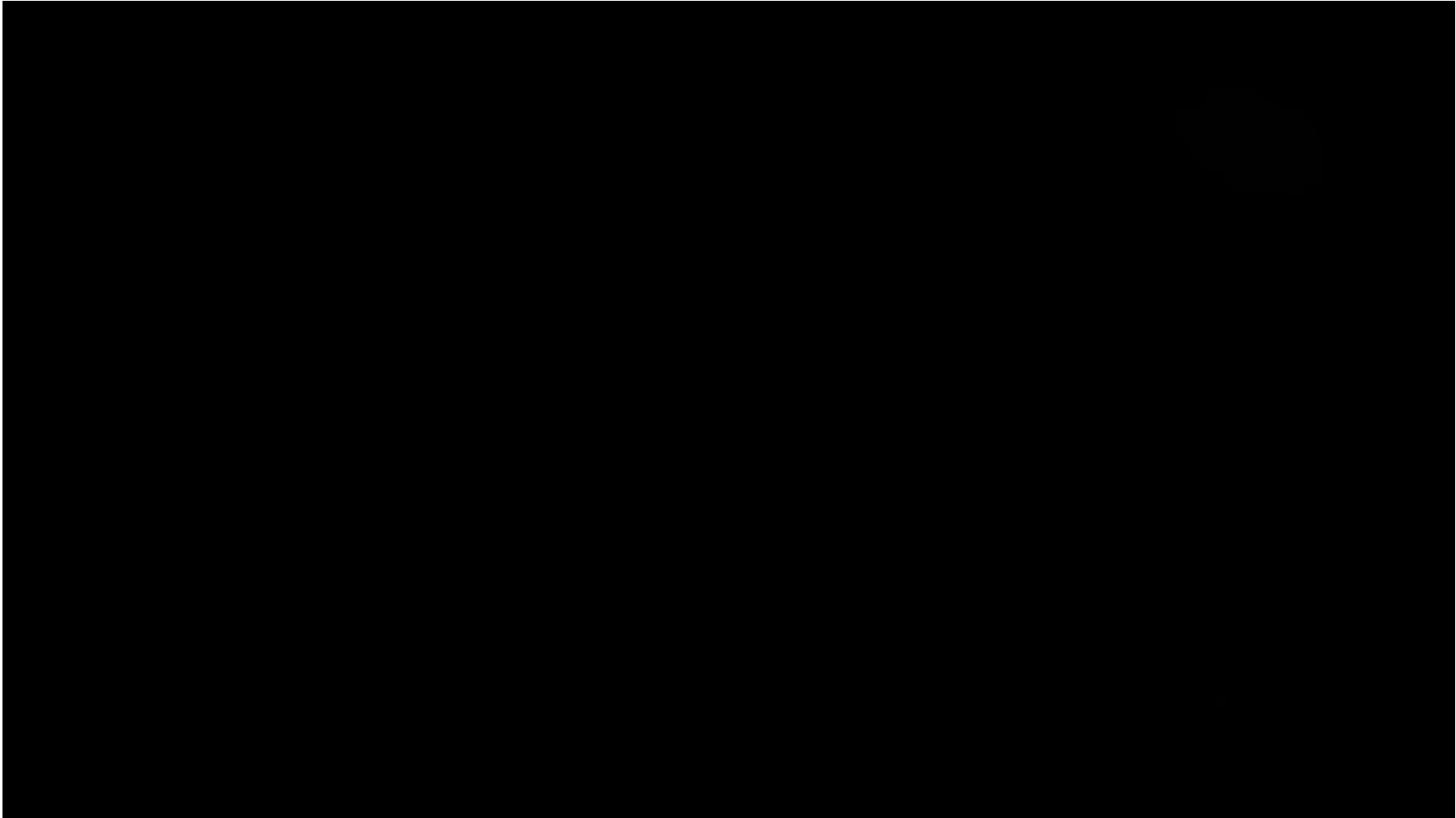












FINAL THOUGHTS
